Information We Collect:

1.1 Information You Provide: When you use the App, we may collect the following information you provide voluntarily:

Personal identification information (such as your name, email address, and contact information) when you contact us or submit feedback.

Payment information (such as credit card details) when making purchases through the App.

1.2 Automatically Collected Information: We may automatically collect certain information when you use the App, including:

3.2 We may share your personal information with:

Service providers: We may share your information with trusted third-party service providers who assist us in operating the App, performing services on our behalf, or analyzing user behavior.

Legal purposes: We may share your information if we believe it is necessary to comply with applicable laws, regulations, legal processes, or enforceable governmental requests.

Business transfers: If we are involved in a merger, acquisition, or sale of all or a portion of our assets, your information may be transferred as part of that transaction.

Data Retention:

4.1 We retain your personal information for as long as necessary to fulfill the purposes outlined in this Privacy Policy or as required by law.

## Data Security:
